## Irrevocable Authorization to be Signed by Next of Kin

I *irrevocably* authorize the execution of the wishes indicated by this document. In addition, by signing this document, I understand the following:

- Any funeral services for the declarant must be conducted at a funeral home prior to the body being transported to Summum. The declarant and/or declarant's family are responsible for the cost of any funeral services and the transportation of the body to Summum. Summum only provides the religious rites of Mummification and Transference.
- The rites of Mummification and Transference are conducted by the temple officiants of Summum and can take a number of months to administer. Once the declarant's body has been delivered to Summum at 707 Genesee Avenue, Salt Lake City, Utah, family, relatives, friends, and any other person will not be permitted access to the body while the rites are conducted. This is to ensure the officiants can perform the Mummification and Transference without interference and in accordance with Summum's principles.
- If any next of kin with legal rights to the declarant's body contests or interferes with Summum administering the rites of Mummification and Transference, Summum will not provide its rites. Should Summum be in the midst of administering the rites when the dispute occurs, the rites will cease and Summum will release the body to the declarant's family.
- If the final resting place of the declarant's mummiform/sarcophagus/casket is the Summum mausoleum sanctuary located at Summum, family, relatives, friends, and any other person will not have access to the sanctuary. Therefore, all final farewells should be conducted before the declarant's body is delivered to Summum.
